#### Document Revision/Lawsuit - Frank DiCicco

History - In 2004, Deed restriction preservations were filed. At the time, this was the best statutorily procedure available to HOAs. This proved to be unacceptable for many HOAs. A few years later, the revitalization statue was provided to HOAs. Jim Burgess and Becker & Polikoff advised MVRIA that revitalization was the best path forward put an end to frivolous lawsuits.
